

MINUTES OF A SPECIAL MEETING OF
BOARD OF TRUSTEES OF FILER
SCHOOL DISTRICT NO. 413
April 17, 2013

A special meeting of the Board of Trustees of Filer School District No. 413 Twin Falls County, Idaho was convened at 7:02 p.m. on April 17, 2013 at the Special Service Conference Room in said district, pursuant to authority provided by Section 33-510 and 67-2340 through 67-2347, Idaho Code, and pursuant to affirmation by the Clerk that notice of the special meeting had been given to each trustee and had been announced by written public notice posted at the school district office and at least two or more public buildings within the school district not less than twenty-four hours before such meeting was to be convened. The Affidavit of Posting of Notice and a copy of the notice of a special meeting of School Trustees were entered into the record and are attached hereto.

Present at the meeting were Trustees Shirley Gailey, Fred Jaynes, Aaron Williams, J. Lea Smith, Superintendent John Graham and Business Manager/Clerk Courtney Bingham when the meeting was called to order at 7:02 p.m. by Chairman Jaynes.

Trustee Gailey made a motion to approve the agenda. Trustee Williams seconded the motion. Motion carried unanimously.

EXECUTIVE SESSION
