SPECIAL SECTION

Retiree Recognition

HEARING SECTION

CMGC Report (Long Range Facility Planning)

Brady Dickinson, Director of Operations for Twin Falls School District, shared their school district's experience with using a CMGC, the newest delivery model for construction. Dickinson shared that using a CMGC is more of a team delivery process that works well in the construction process.
