A special meeting of the Board of Trustees of School District No. 413, Twin Falls County, State of Idaho was convened at 6:01 p.m. on July 30, 2018 at the Filer Intermediate School Library in said district, pursuant to authority provided by Section 33-510 and 67-2340 through 67-2347, Idaho Code, and pursuant to affirmation by the Clerk that notice of the special meeting had been given to each trustee and had been announced by written public notice posted at the school district office and at least two or more public buildings within the school district not less than twenty-four hours before such meeting was to be convened. The Affidavit of Posting of Notice and a copy of the notice of a special meeting of School Trustees were entered into the record and are attached hereto.

Present at the meeting were Trustees Bill Deetz, Judy Hoffman, Bryce Bowman, Chairman Fred Jaynes, Superintendent John Graham, and Clerk Teresa Kullhem when the meeting was called to order at 6:01 p.m. by Chairman Jaynes.

Trustee Bowman made a motion to approve the revised agenda as presented. Trustee Deetz seconded the motion. Motion carried unanimously.

Long Range Planning Committee Recommendations/Bond Proposal

Co-Chairpersons of the Long-Range Planning Committee, Julie Koyle and Jim Hughes, are present with Clint and Jeremy from Pivot North and Michael Keith with Piper Jaffray to present recommendations for moving forward with expansion in the district based on community wants and district needs. These recommendations include: CTE expansion at the high school, improvements to the middle school auditorium, elementary school site development, expansion at the intermediate school, and acquisition of additional land.

Tad Haney was present to discuss the search for additional parcels for the district to acquire for future development.

Michael Keith covered the analysis of what our current bonds look like and what will need to happen moving forward with expansion. The district is looking towards Spring of 2018 for a bond election.
