# MINUTES OF THE REGULAR MEETING OF BOARD OF TRUSTEES OF SCHOOL DISTRICT NO. 413, TWIN FALLS COUNTY, STATE OF IDAHO AUGUST 14, 2018

#### **REGULAR BOARD MEETING**

The regular meeting of the Board of Trustees of School District No. 413, Twin Falls County, State of Idaho was held at the Filer Intermediate School, Filer, Idaho, on August 14, 2018 as provided in section 33-510 and 67-2345 et seq. Idaho Code.

Present when the meeting began at 7:01 p.m. were Chairman Fred Jaynes, Trustees Bryce Bowman, Aaron Williams, Judy Hoffman, Superintendent John Graham, Business Manager Kyle Pryde and Clerk Teresa Kullhem.

Trustee Hoffman made a motion to approve the revised agenda, moving the bus routes from the Conference Section up to the Hearing Section. Trustee Bowman seconded the motion. Motion carried unanimously.

### HEARING SECTION Bond Defeasance

Michael Keith with Piper Jaffray explained what a bond defeasance is and how it can benefit the district. He explained the value to the district and the cost savings. Questions were fielded concerning structure and fees involved in a bond defeasance. This bond defeasance will save taxpayers money and will help maintain the tax levy rate long term.

#### **Presentation of Monsanto Grant**

Jim Gromm, station manager for Seminis Research Facility, comes before the board tonight to present a grant of \$10K to Filer Elementary School for their STEM On-the-Go program. This grant was made available through the Monsanto Group. Principal Peters explained how this science cart will be used in the school.

James Stevenson, regional director for Mid-Columbia Bus Company is present at tonight's board meeting to present the bus routes for the 2018-2019 school year. Bandette and Kate described the routes and what they look like for the year, answering questions from the board.
