

MINUTES OF THE REGULAR MEETING OF
BOARD OF TRUSTEES OF
SCHOOL DISTRICT NO. 413,
TWIN FALLS COUNTY, STATE OF IDAHO
JULY 13, 2021

The regular meeting of the Board of Trustees of School District No. 413, Twin Falls County, State of Idaho was held at the Filer Intermediate School Library, Filer, Idaho, on July 13, 2021, as provided in section 33-510 and 67-2345 et seq. Idaho Code.

Present when the meeting began at 6:45 p.m. were Chairman Aaron Williams, Trustees Judy Hoffman, Bill Deetz, Superintendent Kelli Schroeder, Business Manager Arron Phinney, and Clerk Teresa Kullhem.

Trustee Deetz made a motion to approve the revised agenda as presented. Trustee Hoffman seconded the motion. Motion carried unanimously.

BUDGET HEARING

Business Manager Arron Phinney presented the amended FY21 budget and the proposed FY22 budget. He highlighted a few of the budget account items and gave an overall summary of the proposed budget. ESSER funds and how they are to be spent were discussed. Discussion was held on various accounts and their current balances.

Trustee Koyle entered the meeting at 6:50 p.m.

Trustee Koyle made a motion to approve the FY22 proposed budget. Trustee Hoffman seconded the motion. Motion carried unanimously.

Trustee Koyle made a motion to approve the amended FY21 budget as presented. Trustee Hoffman seconded the motion. Motion carried unanimously.

Trustee Deetz made a motion to approve the consent agenda. Trustee Koyle seconded the motion. Motion carried unanimously.

Superintendent's Report
Trustee Reelection (Zones 2, 3, 5)

Trustee Zones 2, 3, and 5 are up for reelection this November election. Those interested in running for election need to have the necessary paperwork completed and turned in to the District Office by September 3rd.

Spring Testing Results

Superintendent Schroeder presented the Spring ISAT and IRI testing results, comparing them to the State average. Discussion was held on testing and its results and how to better test scores in the future.

ISBA Resolution

The Kimberly School District is sponsoring a resolution that would advocate for a change in the current practice of placing out of state teacher and current administrators on the career ladder. This resolution would give years of experience back to those teachers and administrators. Superintendent Schroeder is asking that the Filer School District also support this resolution.

D.L. Evans Bank Account Changes
