MINUTES OF A SPECIAL EMERGENCY MEETING OF BOARD OF TRUSTEES OF FILER SCHOOL DISTRICT NO. 413, TWIN FALLS COUNTY, STATE OF IDAHO SEPTEMBER 29, 2021

A special meeting of the Board of Trustees of School District No. 413, Twin Falls County, State of Idaho was convened at 4:00 p.m. on September 22, 2021 at the Filer School District Conference Room in said district, pursuant to authority provided by Section 33-510 and 67-2340 through 67-2347, Idaho Code, and pursuant to affirmation by the Clerk that notice of the special meeting had been given to each trustee and had been announced by written public notice posted at the school district office and at least two or more public buildings within the school district not less than twenty-four hours before such meeting was to be convened. The Affidavit of Posting of Notice and a copy of the notice of a special meeting of School Trustees were entered into the record and are attached hereto.

Present at the meeting were Chairman Aaron Williams, Trustees Judy Hoffman, Julie Koyle, Bob Burnham, Bill Deetz, Superintendent Kelli Schroeder, and Clerk Teresa Kullhem when the meeting was called to order at 4:02 p.m. by Chairman Williams.

Trustee Koyle made a motion to approve the agenda. Trustee Burnham seconded the motion. Motion carried unanimously.

Consent Agenda

Trustee Hoffman made a motion to approve the Consent Agenda. Trustee Burnham seconded the motion. Motion carried unanimously. Consent Agenda consisted of: Approval of 9/22/21 Special Meeting Minutes; Approval of Hires; Mariah Haye (FMS SpEd Paraprofessional).

Superintendent's Section District Rezone

Superintendent Schroeder presented the three district rezone plans. Discussion was held on the three plans. Superintendent Schroeder had checked with the state regarding an exemption for the Hollister trustee zone, but it would most likely be quite difficult to get that approved by the State. Trustee Koyle made a motion to approve district zone option 3 and move forward with the boundary line changes. Trustee Burnham seconded the motion. Motion carried unanimously.

ARP Funding

Superintendent Schroeder presented a plan for the ARP funding that the district will be getting through the State. A plan on spending these funds needs to be submitted to the State by October 1st. The administrative team has been working on ideas for distribution of this money. Math curriculum is an area of great need. A minimum of 20% of these funds must be spent on items related to learning loss. Trustee Koyle made a motion to accept the ARP funding plan as presented and for it to be turned in to the State by October 1st. Trustee Deetz seconded the motion. Motion carried unanimously.

Covid Response Update

Superintendent Schroeder presented the school reentry plans, for the reopening on October 4th. The administrative team has worked to put this plan together. Discussion was held on the proposed plan. Each building administrator will be responsible for the day-to-day decisions in their building based on absences. Trustee Koyle made a motion to approve the Filer School District reentry plan as presented. Trustee Burnham seconded the motion. Motion carried unanimously.
