

**MINUTES OF A SPECIAL MEETING OF  
BOARD OF TRUSTEES OF FILER  
SCHOOL DISTRICT NO. 413,  
TWIN FALLS COUNTY, STATE OF IDAHO  
December 9, 2015**

A special meeting of the Board of Trustees of School District No. 413, Twin Falls County, State of Idaho was convened at 7:03 p.m. on December 9, 2015 at the Filer Intermediate School Library in said district, pursuant to authority provided by Section 33-510 and 67-2340 through 67-2347, Idaho Code, and pursuant to affirmation by the Clerk that notice of the special meeting had been given to each trustee and had been announced by written public notice posted at the school district office and at least two or more public buildings within the school district not less than twenty-four hours before such meeting was to be convened. The Affidavit of Posting of Notice and a copy of the notice of a special meeting of School Trustees were entered into the record and are attached hereto.

Present at the meeting were Trustees Carol Ann Lanford, Aaron Williams, Bryce Bowman, Chairman Fred Jaynes, Superintendent John Graham and Business Manager/Treasurer Courtney Bingham when the meeting was called to order at 7:03 p.m. by Chairman Jaynes.

Trustee Williams made a motion to approve the agenda. Trustee Lanford seconded the motion. Motion carried unanimously.

**EXECUTIVE SESSION
