West on 4000 North to 2100 East; thence,

South on 2100 East to said US Highway 30; thence,

Northwest on US Highway 30 to said 4000 North; thence,

West on 4000 North to 2000 East; thence,

South on 2000 East to 3700 North; thence,

West on 3700 North to 1800 East being on the said District Boundary; thence, continuing along said District Boundary the following courses:

North on 1800 East to 4100 North (Pole Line Road); thence,

Northerly meandering on said unnamed drainage to River Road; thence,

Northwesterly approximately 1.1 mile on River Road to an angle point; thence,

Southeasterly then westerly then northerly along said District Boundary to the Snake River and the **POINT OF BEGINNING**.

North on 2100 East to Clover Road (3900 North); thence,  
East on Clover Road (3900 North) to US Highway 30 (3900 North); thence,  
Southeast on US Highway 30 (3900 North) to 2200 East (Stevens Avenue); thence,  
North on 2200 East (Stevens Avenue) to Front Street; thence,  
East on Front Street to 2250 East (Fair Avenue); thence,  
North on 2250 East (Fair Avenue) to 4000 North; thence,  
West on 4000 North to 2100 East and the **POINT OF BEGINNING**.

**BEGINNING** at the intersection of 1500 East and High Line Canal on the West School District Boundary; thence, along said School District Boundary the following courses:

Northeasterly meandering on the High Line Canal to 1600 East; thence,

North approximately 0.5 mile on 1600 East to the east-west centerline of Section 32, Township 10 South, Range 15 East, Boise Meridian; thence,

East approximately 0.5 mile along said line to an angle point; thence,

Southeasterly from said angle point to the High Line Canal; thence,

Northeasterly approximately 0.95 mile on High Line Canal to a point on the extension of 3550 North; thence,

East approximately 0.5 miles on 3550 North to angle point; thence,

North from said angle point to 3600 North; thence,

Easterly on the High Line Canal to 1900 East; thence,

North on 1900 East to 3600 North; thence,

East on 3600 North to State Highway 74; thence,

East on State Highway 74 to 2500 East and said District Boundary; thence,

Southerly, then westerly, then northerly on said District Boundary to 1500 East and the High Line Canal and the **POINT OF BEGINNING**.
